Answer: The heading for this line was omitted in error and should have been "Bistro Equipment Depreciation" Sundry Bistro equipment items previously included within inventory in prior year were reclassified to property, plant & equipment in current year and hence depreciation commenced in current year with no prior year bistro equipment depreciation.

Question on Notice: C. Clark requested further information to include in the minutes pertaining to line item "Other Expenses" for \$864k in revenue.

Answer: Full details for what is contained in the other expenses is included in the Department trading statements and can be found at the end of the Financial Statements in the Annual Report.

Question: A Member queried why there was no mention in any of the Executive Reports of the proposed amalgamation.

Answer: President M. Sarau advised he didn't see a need to include the proposed amalgamation in his report given it was no longer a viable option due to the political interference. Mr Sarau also stated the amalgamation was subject to fierce discussion among Members previously and he wanted to look forward and not rehash on previous discussions that have no bearing on the future of our Club.
